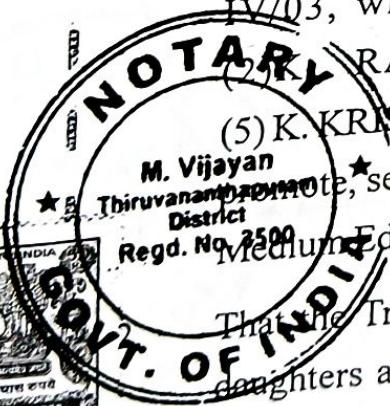
AFFIDAVIT

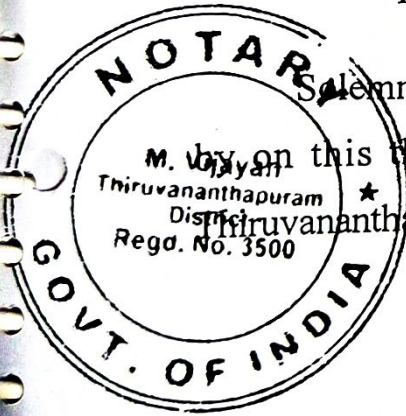

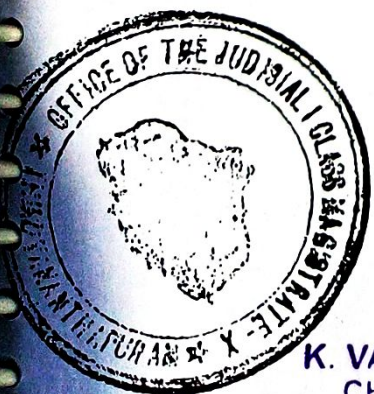
